- Keep a copy of this letter for your records. Our office will not have a copy of this letter until it is returned to us by the lienholder / lessor.
- Contact your lienholder / lessor if you have questions regarding the date they mailed your paperwork to us.
- Our office will notify you when the title is received.

Additional Required Items from Owner / Lessee:

- The vehicle to be titled must be present, or you may submit a completed HSMV Form 82042 Vehicle Identification Number and Odometer Verification. The form can be located on our official website at https://www.sarasotataxcollector.com/downloads/motorist. (Inclement weather conditions may delay vehicle identification number (VIN) verifications performed at our offices.)
- Proof of current Florida insurance.
- Each title applicant must be present with their identification (see below), or an appointed Power of
 Attorney must present an original or a certified copy of the Power of Attorney document (along
 with their own identification) and a copy of the applicant's identification.
- If your vehicle was purchased within the last six months, you must submit proof of the purchase
 price and proof of any sales tax paid. Additional taxes equivalent to Florida's sales tax or local tax
 may be due.

Acceptable Proof of Identification:

- A valid driver's license or identification card issued by Florida or any U.S. state or territory.
- A valid Canadian driver's license or identification card.
- A valid passport or passport card from any country.
